In 2018 Adrian Kearns, Senior Project Manager at Black Country Healthcare NHS Foundation Trust, procured an Electronic Document Management System (EDMS) to easily manage digital patient records. To leverage this tool, the Trust required a capable document scanning solution, able to output high-DPI colour scans and meeting specific healthcare industry standards. Having had a positive experience with PFU (EMEA)'s image scanners previously, the Black Country NHS second line and engineer teams have always used and trusted PFU (EMEA)'s image scanners.

A year later, the Trust rolled out its Electronic Patient Record (EPR) system, called RIO, allowing for digital management of patient records. However, due to copyright issues on a variety of forms, there were considerable scanning requirements for data that could not be entered into the system. Because of impressive results in terms of document management and data capture, Adrian enhanced the solution they already had in place.

Working closely with technology reseller BIST Group, Bingley, the Trust was able to easily secure a significant number of SP-1425 units. BIST managed both the logistics and implementation of the scanners, providing the Black Country team with the robust scanning capabilities they were looking for.



The COVID-19 pandemic made things even more challenging, as it led to a substantial need for document capture to support the Trust's continued EPR rollout. Given this requirement and the work from home transformation, several scanners were implemented on-site to help streamline patient record management throughout the organisation. This also reduced the number of people in one area, making it in line with government social distancing advice. BIST provided much needed flexibility and support, with readily available stock.

The Black Country Healthcare NHS Foundation Trust has greatly benefited from the scanners' durability and ease of use– streamlining and driving efficiency in patient data management. The ability to acquire scanners with the resolution, speed and capture capability required was invaluable during the pandemic.

However, the benefits were not limited just to the scanners themselves. BIST provided full support, understanding and commitment to stock delivery, particularly during the start of COVID19. Despite the period being challenging in terms of new kit availability, the Trust was reassured that they could deliver on operational times and given the confidence that both PFU (EMEA) Limited and BIST would provide the necessary support.
