1. Cautions in using Windows Vista(R) / Windows(R) 7

- * CardMinder does not support system-dependent characters (Unicode).
Do not use such characters for names of the following:
 - CardMinder installation folder
 - Users to use CardMinder
 - Folders and files to be handled in CardMinderIn addition to those above, do not use system-dependent characters for anything to be handled in CardMinder

2. Cautions during Installation

- * For details about supported operating systems, refer to "System Requirements" in the Operator's Guide of your ScanSnap model.

Note: CardMinder does not support some Windows functions such as Switch User and Remote Desktop operation.
- * Do not install this software in the root directory. CardMinder may not function properly.
Install CardMinder in the appropriate directory.
- * The path name for the installation directory will automatically be generated in DOS short form if it exceeds 104 characters.
When installing CardMinder, limit the path name for the installation directory to 104 characters or less.
- * Be sure to log on as a user with Administrator privileges to install the program.
- * Do not use the following characters in the name of the installation directory.
CardMinder may not function properly if these characters are used.
/ ; . * ? " < > | # %
- * When you start installing the program in the computer running on Windows Vista(R), Windows(R) 7,
the User Account Control dialog box appears.
Click the [Continue] button.
- * Select a local folder as the installation folder.
- * To use the following functions, you need to install .NET Framework 3.5 (SP1 or later) first.
 - Salesforce linkage

3. Cautions during Uninstallation

- * Be sure to log on as a user with Administrator privileges to uninstall the program.
- * To uninstall CardMinder, close CardMinder first. Open [Add or Remove Programs] in [Control Panel], select [CardMinder] and follow the instructions on screen.
- * "Are you going to remove shared file(s)?" message may be displayed. If you remove the files, whereas any programs are still using the file(s), those programs may not function properly.
If you are not sure what to do, it is suggested that you choose to not remove the shared file(s). Leaving the file(s) will not harm your system.

- * After uninstalling the program, restart the computer, and then log on as a user with Administrator privileges.
This completes the uninstallation of the program.
- * When you start uninstalling the program in the computer running on Windows Vista(R), Windows(R) 7, the User Account Control dialog box appears.
If you are a user with Administrator privileges, click the [Continue] button.
If you are not, select the name of a user with Administrator privileges, enter the user password, and then click the [OK] button.

4. Cautions during Execution

- * Supported resolutions for Recognition functions are as follows:
To scan in color: 150dpi or more. 300dpi is recommended.
To scan in B&W: 300dpi or more. 400dpi is recommended.
- For ScanSnap Manager: "Best" is recommended.
- * When CardMinder recognizes a Chinese and Korean business card, the ScanSnap needs to be ready to scan. Be sure the ScanSnap is powered on and the ScanSnap icon on the task bar indicates the state is in operation.
- * You can put line feed control codes in the fields of address, memo, and the like.
However, when the data of those is exported to an application and is saved with the application, the line feed codes will be excluded.
- * If you log on as a user without Administrator privileges, other applications may not interact properly with CardMinder.
- * To use CardMinder in Windows(R) 2000 or Windows(R) XP Professional, log on as a user with privileges higher than those of standard users (in the Power Users group).
In Windows(R) XP Home Edition, use an Administrator account.
In Windows Vista(R), Windows(R) 7, log on as a user with privileges higher than those of standard users.
- * CardMinder user interface language changes to English if the Windows language is not Chinese, English, French, German, Italian, Japanese, Korean, or Spanish.
- * Key combination assigned as Hot key used for searching is valid only for CardMinder Viewer.
- * Country code is automatically added to the Phone number, FAX number and Mobile phone number data to be exported to ACT!.
- * When using CardMinder V1.1, "This version is old DB format. Do you convert the DB format?" message appears.
If you want to import the data from CardMinder V1.1, select [Yes]. If you want to create a new database, select [No], and then select [Yes] in the next "Do you create a new CardMinder V4.1 database?" dialog box.
- * Set the display resolution to 800 x 600 pixels or more when using CardMinder.
Note: When the font size is large, some screens may not be displayed properly.
In that case, use a smaller font size.
- * Display Color settings
Medium/High Color (16 bit) or higher.
(If you specify 256 colors, the display screen may be disturbed.)
- * If text is not displayed properly during:
 - Text recognition and display of business cards
 - Salesforce linkage

change the settings as follows:

Windows(R) 2000:

- Select [Control Panel] -> [Regional Options] -> [General] tab, and then select [Japanese], [Korean], [Simplified Chinese] and [Traditional Chinese] under [Language settings for the system].
- Install Universal Font (Arial Unicode MS) from the Setup Disk of Microsoft Office 2000 or later version.

Windows(R) XP:

- Select [Control Panel] -> [Regional and Language options] -> [Languages] tab, and then select [Install files for East Asian languages] under [Supplemental language support].
- Install Universal Font (Arial Unicode MS) from the Setup Disk of Microsoft Office 2000 or later version.

Windows Vista(R) or Windows(R) 7:

- Install Universal Font (Arial Unicode MS) from the Setup Disk of Microsoft Office 2003 or later version.

5. Changes from the previous version

Changes from V4.0L10 to V4.0L11

- * Previously, when the operating system was configured to enable the policy to prohibit the display of most recently used (MRU) lists, you could not start up CardMinder. This problem has been corrected.

Changes from V4.0L11 to V4.1L10

- * Online updates are available also from the start menu.
- * Removable disks are also available for data transfer using the Mobile Linkage function.

Changes from V4.1L10 to V4.1L20

- Added a function to create a double-sided card image from a single-sided card image.
- Icons (e.g. Front/Back) were changed to improve usability.
- Modified the error in which business cards cannot be scanned after denying access to Outlook when linking with Outlook.

Changes from V4.1L20 to V4.1L30

- Added the Salesforce linkage function.
- Modified to exit CardMinder after completing the scan when the [Show CardMinder window] check box in [Options after scanning] is not selected.

Changes from V4.1L30 to V4.1L40

- Modified the card data list in the main window so that the order of items (e.g. Full Name, Company etc) can be changed by drag & drop.
- Default settings related to Salesforce linkage were changed.
- Modified the [Location/Region] drop-down list to display the items in alphabetical order.

Changes from V4.1L40 to V4.1L50

- Fixed the error where WIA driver appears in the [Select Source] window when selecting a scanner.

Changes from V4.1L50 to V4.1L52

- The [Select Group] dialog box does not appear when the Lead setting is disabled at Salesforce linkage.
- While multiple card data are selected and [Recognize] is clicked, the memos of the card data that are not currently displayed are cleared.
